

LICENSE AGREEMENT

for the right to use the work

State Budgetary Scientific Institution of the Republic of Khakassia “Khakass Research Institute for Language, Literature, and History”, hereinafter referred to as the “Licensee”, represented by Acting Director Nina Semyonovna Mainagasheva, acting on the basis of the Order of the Ministry of Science and Education of the Republic of Khakassia № 5-293 of December 18, 2019, on the one hand, and the Author (co-authors)

hereinafter referred to as the “Licensor”, on the other hand, and together referred to as the “Parties”, have concluded this Agreement as follows.

1. Subject of the Agreement

1.1. The Licensor undertakes to grant the Licensee the non-exclusive right to use the Work created by him within the limits established by this Agreement, and the Licensee undertakes to accept the corresponding non-exclusive right and use it within the limits established by law and this Agreement.

1.2. The object of copyright, the right to use which is granted under this Agreement, is a scientific article _____

_____, hereinafter referred to as the “Work”.

1.3. The Licensor undertakes to grant the Licensee the right to use the Work as follows:

1.3.1. disclosure of the Work;

1.3.2. distribution of copies of the Work by any means;

1.3.3. import of the original or copies of the Work for distribution purposes;

1.3.4. making the Work available to the public by broadcasting or by cable or by other similar means.

1.4. The territory, where the use of the Work is allowed, is not limited.

1.5. The rights to use the Work are granted to the Licensee, while the Licensor retains the right to issue licenses to other persons.

2. Rights and obligations of the Parties

2.1. The Licensee may use the Work only within the limits of those rights and by those means that are stipulated by this License Agreement.

2.2. With the written consent of the Licensor, the Licensee may, under the sublicense agreement, grant the right to use the Work to another person within the limits of those rights and those ways of use that are stipulated by the license agreement for the Licensee.

2.3. During the term of this License Agreement, the Licensor is obliged to refrain from any actions that may hinder the Licensee's exercise of the right to use the Work within the limits established by the Agreement.

3. Duration of the Agreement

3.1. The rights specified in Clause 1 of this Agreement are transferred by the Licensor to the Licensee for the duration of the copyright.

3.2. In case of termination of the exclusive right, the License Agreement is terminated.

4. Remuneration of the Licensor

4.1. No remuneration is provided for the use of the Work. The granting the right to use the Work is carried out free of charge.

5. Liability under the Agreement

5.1. For the use of the Work in a way not stipulated by this Agreement, or upon termination of the Agreement, or otherwise outside the rights granted by the Agreement, the Licensee is responsible for the violation of the exclusive right to the Work established by the Civil Code of the Russian Federation and other laws and regulations.

5.2. The Licensor guarantees ownership of the exclusive rights to the Work provided under this Agreement.

6. Final Provisions

- 6.1. This Agreement comes into force from the moment of its signing.
6.2. This Agreement is drawn up in two authentic copies - one for each of the Parties.
6.3. In everything that is not provided for in this Agreement, the Parties are guided by the common law.
